I am submitting this formal claim as a creditor of API.VIDEO (SAS, SIREN: 491 182 739), which entered judicial liquidation on 29 January 2025, as per the Tribunal de Commerce de Bordeaux's judgment

### Claim Details

Creditor Name: Cassilouise Blesovsky  
Company Debtor: API.VIDEO, 26 Quai de Bacalan, 33300 Bordeaux, France  
Amount Claimed: £20,000  
Basis of Claim: Contractual settlement payment due under the Amendment to Employment Contract for Financial Protection, dated 1 July 2024  
Trigger Event: Company's liquidation and cessation of operations, as stipulated in the contract amendment.

### Nature of Claim - Unsecured, Due, and Payable Contractual Debt

My claim arises from a contractual settlement payment due under my Amendment to Employment Contract for Financial Protection, signed on 1 July 2024. This agreement, which is supplemental to my employment contract, explicitly states:

The amendment does not modify or replace my employment contract but instead provides additional financial protection in case of company insolvency (Clause 2.1) AMENDMENT TO EMPLOYMENT CONTRACT FOR FINANCIAL PROTECTION - Cassi Blesovsky

Upon company insolvency and cessation of operations, a settlement payment of £20,000 becomes immediately due (Clause 1.2 and 1.3) AMENDMENT TO EMPLOYMENT CONTRACT FOR FINANCIAL PROTECTION - Cassi Blesovsky

The settlement payment is separate from and in addition to any other employment-related entitlements, including notice pay

As API.VIDEO has entered judicial liquidation, my entitlement has been triggered, and the payment is now due and payable under the terms of the contract.

While this claim is contractual and therefore classified as unsecured, I request consideration for privileged treatment under French insolvency law, given that:

The claim relates to an employment-related financial protection scheme that compensates employees for a lack of statutory insolvency protections. The obligation was contractually agreed to protect against financial hardship upon company liquidation, aligning with the intent behind privileged employee claims under insolvency law.

#### Company's Judicial Liquidation Process & Insolvency Timeline

Week of 18 November 2024: API.VIDEO commenced judicial insolvency filings, notifying the court of its cessation of payments, marking the beginning of the insolvency process

10 December 2024: The Tribunal de Commerce de Bordeaux placed the company under judicial recovery (redressement judiciaire)

29 January 2025: The company was officially declared in judicial liquidation, triggering my contractual entitlement

Since API.VIDEO was already in financial distress in November 2024, my contractual entitlement to the £20,000 settlement payment became effective at the outset of the insolvency proceedings.

#### Requested Action

I kindly request acknowledgment of this claim and confirmation of when I can expect payment. Please also confirm the timeline and process for creditor disbursements.
